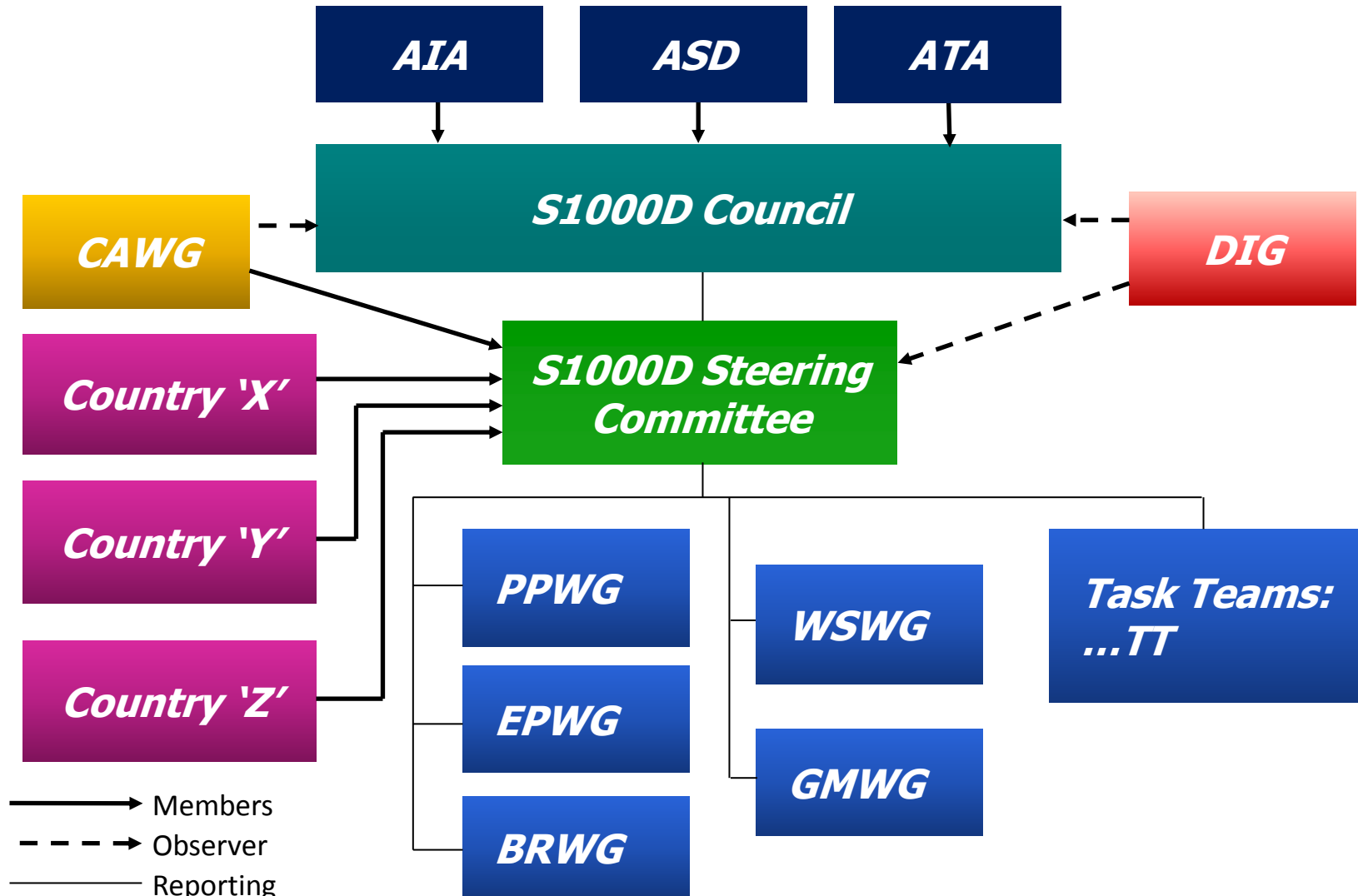

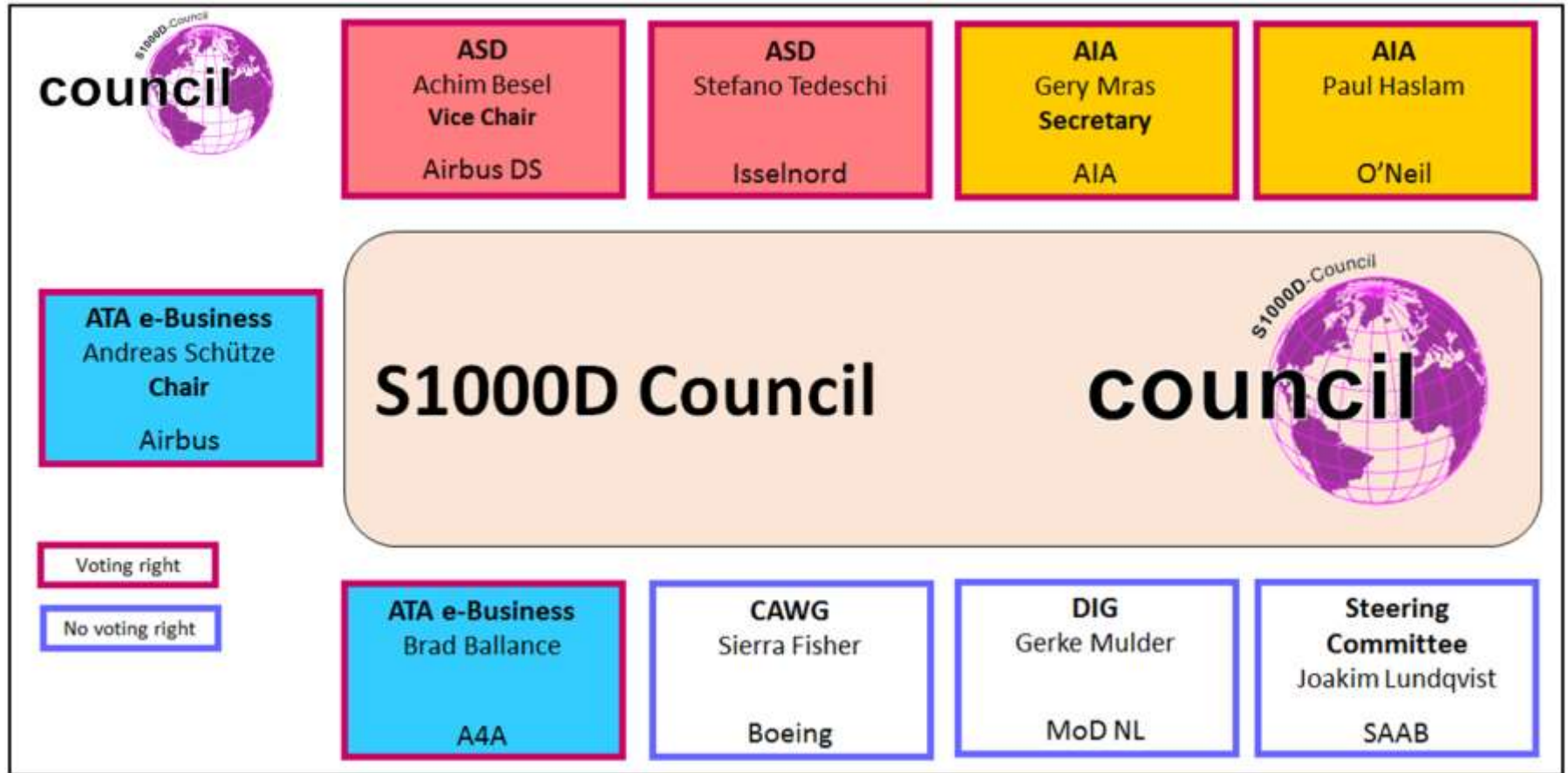

## Participation in S1000D - Categories

### Members

- Member nations
- Member organizations

### Participants

- **Non-affiliated observer**
  - Represents an industry or customer consortium not associated with one of the S1000D parent organizations
  - One observer seat on the Steering Committee but no WG/TT participation
  - Approved by the Council (MOU) - One year time limit
- **Non-affiliated participant**
  - Represents an industry or customer consortium not associated with one of the S1000D parent organizations
  - One observer seat on the Steering Committee and full WG/TT participation
  - Approved by the Council (MOU)
- **Emeritus**
  - Is a former representative of a full or non-affiliated member
  - Can participate in WG/TT
  - Must be approved by the S1000D Council (IP agreement)
- **Invited expert**
  - Is allowed for individual participation upon invitation of the WG/TT chair
  - Is not member of S1000D SC or any WG/TT
  - Must be approved by the S1000D Council (IP agreement)

## Participation in S1000D - Application status

### Application status per category

#### – Non-affiliated participant

- ✓ Shipdex: MOU (for non-affiliated participant status) signed by applicant and all three parent organizations
- ❖ NSPA: MOU provided for signature. Currently internal evaluation in NSPA. Application in progress.
- ❖ OCCAR: MOU provided for signature. Currently internal evaluation in OCCAR. Application in progress.
- ❖ Australia: MOU with Australian MOD envisaged. Application in progress.
- ❖ Canada: S1000D Council received two separate inquiries from Canadian companies for active participation in S1000D arena. Application in progress.

#### – Emeritus

- ✓ Five IP agreements signed. Individuals furthermore actively support activities in S1000D international arena.

#### Remark:

Due to retirement of some current S1000D SC members in the next future, further agreements are expected.

## Vision, Mission, Goals - Update [1/2]

**The S1000D Council updated the Vision, Mission, Goals to reflect the future requirements in the perimeter of S1000D**

### Vision

*“To be the **most globally adopted specification** for efficient interoperable technical information in the product support life cycle.”*

### Mission

*“To provide a **forward-looking, modular, platform-neutral specification** utilizing **standardized data structures and business rules** to enable the global user community to **optimize reuse and interoperability** of technical information.”*

## Vision, Mission, Goals - Update [2/2]

### Goals

- Maximize management and reuse of data by specifying a data-module concept for structuring technical information.
- Maintain a modular specification based on foundation and building blocks.
- Enable project-level customization of the specification.
- Facilitate information interoperability by maintaining data integrity, standardizing data structures, and requiring semantic and syntactic consistency.
- Strive for one solution and method for achieving the same business requirement whenever possible.
- Maintain awareness of, support, and employ new technologies as required.
- Integrate approved end user requirements in a timely manner.
- Employ a well defined, efficient, effective and consistently-applied specification change and publication process.
- Foster global adoption of the specification by regular public events and other activities, making it easy to access, tailor and implement.
